MINUTES FOR THE

2021-1ST IAMD COE STEERING COMMITTEE MEETING (SCM I-2021)

held virtually via Video Teleconference (VTC) on 3rd June 2021

A. Opening remarks

The SC:

- noted the introduction by the B.Gen. K. Zolotas, SC Chairperson (CP) in welcoming the
 participants to the 2021 1st IAMD COE Steering Committee Meeting (SCM). The CP
 expressed his certainty and wishes for the conduct of a fruitful meeting, which had to
 be held on-line, due to COVID-19 travel restrictions and ongoing preventive measures
 related to public gatherings.
- 2. noted the introductory remarks by Col E. Tzikas, IAMD COE Director.

B. Approval of Observers' participation and the SCM Agenda

The SC:

- noted participation via VTC of the Framework Nation (Greece) and all Sponsoring Nations (Bulgaria, Czech Republic, Romania and Turkey), observers from France and Slovakia, ACT/ FOGO Champion and ACT. The meeting attendance list is reflected in Annex "A".
- 2. noted that no comments were made by members on the tentative agenda of reference (a) document.
- 3. noted IAMD COE Director's proposal on the following, additional, topics to be presented under the corresponding Agenda Items:

1. noted the presentation by IAMD COE CoS, addressing the main aspects of IAMD COE action plan development and an overall progress of Centre's activities (PoW).

The SC:

- noted reference documents (c)-(d) and the associated presentation by IAMD COE PoW Manager on 2020 POW execution and 2021 PoW progress respectively, covering the following areas: Exercises, Working Groups, Courses & Conferences and RFS Summary.
- 2. noted IAMD COE's clarifications on the PoW comments raised by TUR, as depicted in the RAP comments list (Annex "D").
- 3. noted reference documents (e) and the associated presentations by IAMD COE staff on nine (9) new Items to be included in 2021 PoW. It was highlighted that financial impacts of the subject activities will be covered from the existing budget (and by transferring of appropriations within the authorization granted to the Director in accordance with Financial Administrative Procedures, if required) without the need for a supplementary budget.
- 4. noted the following discussion/comments by:

ROU: Expressed its concerns on managing limited Centre's resources, based on the wide spectrum of presented initiatives, and risk to lose focus on IAMD core areas.

ACT SME: Agreed on ROU's comment and provided clarifications regarding PP 10.g. to exhibit how several initiatives can relate with IAMD focus areas.

TUR: Agreed on the need to focus on core IAMD areas and requested IAMD COE to assess the value of participation in such broad activities. It also requested, regarding PP 10.e, IAMD COE to investigate a potential agreement with NMIOTC, aiming to cost reduction of COE's training fees.

IAMD COE Director: Agreed with above-mentioned ROU and TUR comments, and reassured that the Centre plans participation in new initiatives, always taking into account its resources, and continuously reviews/reassesses the purpose for dedicating them, based on the whole PoW evolution and Centre's priorities. Regarding the NMIOTC, he stressed that TUR's proposal will be investigated in the view of any future agreement with this organization.

E. IAMD COE relationships with other entities

- 2. **Unanimously agreed** on the eligibility of IFESO as a potential supplier and authorized the signing of a contract with IAMD COE, provided that both sides reach to an agreement.

3. noted reference (g) document and the associated Framework Agreement for Cooperation between IAMD COE and the TurboLab – TUC.

F. Finance and Budget

Ref. Doc.: h. IAMD COE/NU.135/14 Apr 21 (PP-5, Financial Issues)

The SC:

- 1. noted the ref. document (h) and the associated presentation by Financial Controller (FINCON) on 2020 Financial Statements (FS) and the Status of the Participants' contributions for the Fiscal Year (FY) 2021.
- 2. noted IAMD COE's request for approval of FS 2020, by CZE ROU TUR (BGR and GRC have already approved via e-mail). Subsequently, CP requested nations to approve the FS 2020:

CZE: Approved ROU: Approved TUR: Approved

- 3. noted FINCON's clarifications on the comments raised by ROU, as depicted in the RAP comments list (Annex "D"). He stated that TUR had not yet paid its contribution, and all required actions have been taken by the Centre, according to the provisions of the MoU and FAPs. He also stressed that the non-payment of the contribution by Turkey for FY 2021, will result in a revision of the approved budget 2021 and for this purpose, the Centre will prepare a plan to reduce its expenses, if necessary, with a view not to affect, if possible, the smooth execution of its POW and also to avoid any need for a supplementary budget.
- 4. noted the following discussion/comments by:

<u>CP</u>, briefed the SC members, according to his responsibilities to oversee the execution of SC meeting decisions, as follows:

- On 7 April 2020, the Turkish SACT NLR informed SACT LEGAD and all other NLRs, that Turkey's internal procedures regarding MOU's approval, would have been completed by 2020.
- ii. On 1st IAMD CoE SC meeting, during 9-11 September 2020, Turkey had requested more time for further elaboration of the POW 21 and Budget 21. SC members agreed on that and on 30 November 2020, Turkey approved the above mentioned documents.
- iii. I.a.w. the FAPs, the Centre has informed:

- a. The TUR SC representative about the non-payment of his Nation's contribution (after the expiry of the 90-day period following the receipt of the Call for Fund).
- b. The SC Chairperson who in turn informed via e-mail all SC members, and also requested Turkey, to fulfill its relevant obligation of the payment as soon as possible.
- iv. Undoubtedly, all nations have shown good faith regarding the bureaucracy procedures but at the same time and in the light of the above, it is self evidenced (since Turkey approved PoW and Budget 21) that Turkey has to pay its contribution for 2021, as soon as possible.

GRC informed that:

- i. On 5 May 2021, Greece received a written notice by the Turkish Embassy in Greece, saying that Turkey completed its internal procedures, concerning the Operational and Functional MoUs with reservations.
- ii. Greece, on 12 May 2021, asked for clarifications regarding the aforementioned Turkey's written notice, which have not been answered yet, by the Turkish side.

<u>CP</u> thanked GRC and in the light of the aforementioned information regarding CFF 21, asked TUR to inform the SC, about Turkey's intentions. He also asked either for payment completion or for an official commitment / answer, to be given to the members of SC, by the end of July 2021.

TUR provided an official statement as follows:

"Turkish Ministry of National Defence Budget and Financial Division has the authority to pay the contribution of Turkey to an international organization such as IAMD COE, JAPCC, or any other COE etc. In order to pay that contribution, the MOUs must be signed by a Turkish representative first, then approved by Turkish President and finally come into effect and promulgated by Turkish President after the exchanging of memorandum between Turkey and Framework nation (for example Greece for IAMD COE).

For the procedures that I've tried to explain above, Turkey completed the first and second step, and trying to finish for the last issue. I mean our President signed and approved the MOUs in April 2021, then Turkish MoFA wrote an official letter in the beginning of May 2021 to MoFA of Greece for exchanging of memorandum between two countries.

So, for accelerating the process, the Framework Nation may communicate with the Turkish MoFA as soon as possible. As soon as the last step has been completed, Turkey will pay its contribution to IAMD COE immediately.

I'm always in touch and close cooperation with our MoFA and try to do our best. I wish it will be solved very soon. There is no problem for Turkey about not to pay our contribution deliberately, it is just about bureaucratic procedures and is about only this Fiscal Year 2021, I'm sure that there will be no problem and delay for the following years.

Finally, I don't see any reason to make a revised budget plan for 2021. "

ROU: Requested FINCONs clarification on possible effects on Budget 2021 implementation, due to the above situation.

FINCON noted that it may not be a problem for the Centre to receive TUR contribution within the upcoming period, however, he stressed that i.a.w. Operational MoU and FAPs, the Centre shall submit a draft Budget for the next FY (2022), NLT 1st Sep 21, so any relevant information/notification about the progress-intentions of TUR are recommended to be given, if possible by the end of July 21.

IAMD COE Director: Added that the current status of contributions has minimum impact on Centre's activities, due to COVID-19 pandemic for years 2020-2021.

BGR stated that they will not support any increase of their contribution for FY 2021.

LEGAD asked for a clarification in the first paragraph of the above TUR statement, regarding the budget of year 2021, stating "exchanging of memorandum between TUR and the Framework nation".

LEGAD commented that, from her point of view, that refers to the reservation by the Turkish NLR when signing the Memoranda of Understanding that requests for a receipt by the FN of the notification that TUR has completed its internal procedures according to TUR's national legislation.

TUR agreed with the above comment of the LEGAD and also agreed that after the aforementioned receipt, there will be no bureaucratic restraint for paying the TUR contribution for FY 2021.

- 5. noted the aforementioned statements by TUR to fulfill its relevant obligation about the contribution pending (for FY 2021), within the year 2021, after the completion of the bureaucratic internal procedures.
- 6. noted SVK that stated its intention to remain as observer. However, they requested access to IAMD COE products if possible, without positioning personnel (as a Sponsoring Nation) at the Centre. FINCON & LEGAD agreed to investigate a potential framework for partnership.

It was highlighted that the four new posts that are funded by the framework nation, do not drive any financial impact on COEs shared budget and raise the workforce of IAMD COE from thirty-eight (38) to forty-two (42).
