PURPOSE: To inform the SC about the Financial Status of the Centre regarding the

Participants' contributions for the FY 2021.

BACKGROUND: Based on the approved shared budget 2021, the Director submitted to

the Participants the 1st Call For Fund (CFF) for FY 2021, payable within 90

days of its receipt (i.g. by 15 Mar 2021).

The status of the Participants' contributions for FY 2021 was presented in the $1^{st}/2021$ SC Meeting given that one Participant's contribution is pending (TUR: $32.000 \in$).

The SC noted the statements made by Turkey to fulfill its obligation about the contribution pending (for FY 2021), within the year 2021, after the completion of the bureaucratic/administrative internal procedures.

By 30 Sep 21 no payment of the Turkey's contribution has been received.

ANALYSIS & STATUS:

In principle, taking into account the current budget execution, no burden for the FY 2021 has arisen, and also not estimated to be arisen by the end of the year, due to the non-payment of the abovementioned share.
