**PURPOSE:** To inform the SC about the intention of IAMD COE to participate in the initial NATO LRC workshop activities (Oct 21 – virtual) and the upcoming one (Nov 21 – live).

**BACKGROUND:** In May 2019, NATO decided to develop two high-level and coordinated concepts. The Concept for the Deterrence and Defence of the Euro-Atlantic Area (DDA), and the NATO Warfighting Capstone Concept (NWCC). Both concepts together support the Alliance ability to successfully deter and defend against any threat from any direction. The NWCC, as an overarching warfighting capstone concept, will inform the development of NATO's Military Instrument of Power (MIoP) to ensure that NATO maintains and continues to build decisive military advantage.

**ANALYSIS & STATUS:** NATO Concept for Layered Resilience, focused on Military Instrument of Power, that considers both Civil and Military resilience layers, the interdependencies between them, and associated considerations for Warfare Development. COE contribution to the Concept proposal will be invited through activity in (Oct 21 – virtual) and (Nov 21 – live workshop). The proposal will map the subsequent program of work, including opportunities for COE contributions.

Participation of IAMD COE is considered to be permanent in every Workshop-WG, and the estimation is for 2 or 3 meetings per year. In case any
