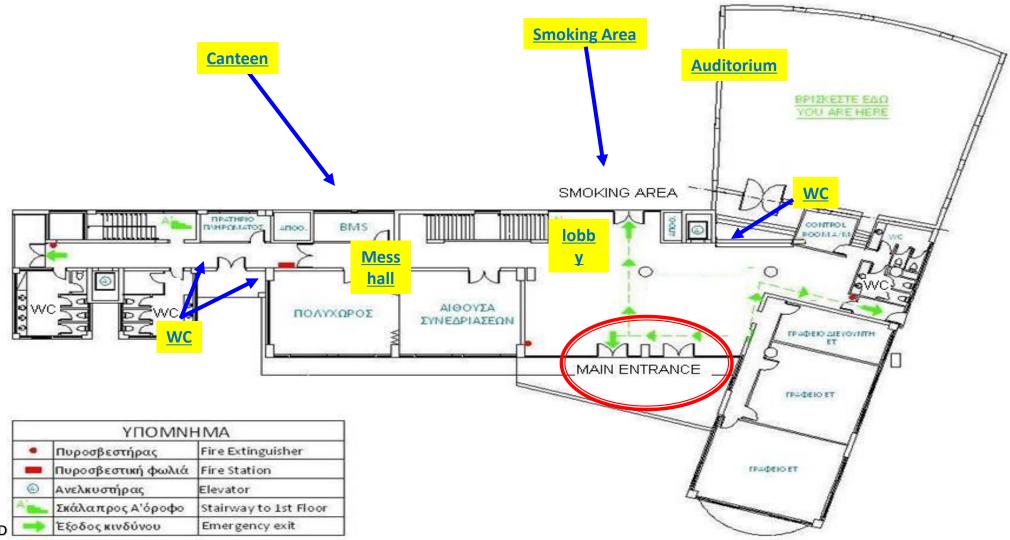

 PCR (last 72 hrs) are required for this conference.

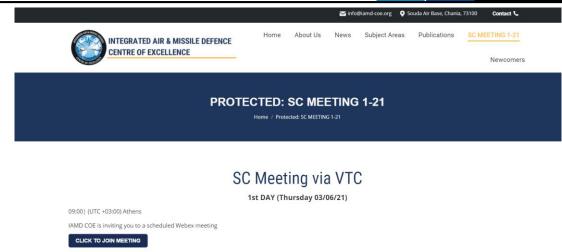
- All Decisions/approvals shall be taken by roll-call vote to SC Members
