1.6 The “ΚΟΜΠΙΟΥΤΕΡ ΠΑΠΑΔΟΥΛΑΚΗΣ ΙΚΕ” (TAX ID Number: EL801615160, Zymvrakakidon & Mariakaki, Chania, 73135, Greece) proposal, dated 29 December 2021;

1.7 The following:

1.7.1 Evaluation strategy: The evaluation was focused on the information provided by the bidders, keeping in mind the most financially profitable solution for the IAMD COE. Bids were evaluated under the factor of lower cost;

1.7.2 Compliance and eligibility: It has been certified that the bidders and their bids are in full compliance with the bidding terms and instructions, the general provisions (terms - conditions) and the special provisions - technical specifications defined in the respective IFB in order to be accepted for further evaluation;

1.7.5 Cost-effective and efficient contracting: It is ensured that the prospective contractors are in compliance with the procurement terms and conditions achieving the most cost effective and efficient solution for the Centre's needs;


2.2.1 Proceed with the signing of the respective contracts following this award decision, according to the Centre's FINCON - P&C Officer instructions;
