1.4 The Invitation For Bidding (IFB) No FINCON 22-05, as Reference E, concerning the writing, delivering and publishing of a review paper-report (including an extended abstract) under the subject "*Overview of international hypersonic weapons programmes, and potential ways to exploit physical phenomena around Hypersonic Weapons to improve surveillance capabilities (Detection and Tracking).*" in favour of the IAMD COE;

1.5 The "Technical University of Crete (TUC)" (Special Account for Research Funding of the Technical University of Crete TAX ID Number: EL 090087411, TUC University Campus, Kounoupidiana, 73100, Greece) proposal, dated 25 July 2022 (13:19), as received through sourceONE internet application (Request for Quote with code: fnc-iamd-132953);

1.6 The following:

1.6.1 Evaluation strategy: The evaluation was focused on the information provided by the bidder, keeping in mind the most financially profitable solution for the IAMD COE;
