<u>PURPOSE</u>: SC to approve the IAMD COE Internship Programme Directive.

BACKGROUND:

Since the Centre has already received two (2) requests by individuals expressing their willingness to attend internship program, a Directive has been prepared in order to lay out the relevant framework with all necessary details, in order to be able as soon as possible to welcome interns, as it has been declared in SC 2/2021.

ANALYSIS & STATUS:

- 1. According to the par. 6.11 of IAMD COE Operational MOU, the Centre may establish an internship program with details set forth in an internship regulation. An intern is not an employee of the IAMD COE and should not be considered as part of the personnel of the IAMD COE. Approving the IAMD COE Internship regulations is under SC responsibility, according to Annex B, IAMD COE Op. MOU.
- 2. In the light of foregoing, the Directive prepared addresses the basic framework elements, including the following:
 - a. Purpose and main objectives of Internship Programme.
 - b. The fields of interest and the skill set the Centre is interested in.
- c. The eligibility criteria that an applicant must meet in or-der to qualify for the internship.

- e. Conditions for Internship (Legal, financial, insurance, security etc.).
