1.2 The Circular of the Hellenic Independent Authority for Public Revenue, as Reference C, concerning the tax exemption of the IAMD COE supplies and services;

1.3 The Commitment of Appropriations, as Reference D, regarding the commitments of funds for the procurement of computers and peripherals;

1.4 The Invitation For Bidding (IFB) No FINCON 22-07, as Reference E, concerning the supply of computers and peripherals in favor of the IAMD COE;

1.5 The "COMPUTER PAPADOULAKIS P.C." (TAX ID Number: EL 801615160, Zymvrakakidon and Mariakaki, Chania, Crete, 73136, Greece) proposal, dated 11 August 2022 (11:01), as received through sourceONE internet application (Request for Quote with code: fnc-iamd-133984);

1.6 The following:

1.6.1 Evaluation strategy: The evaluation was focused on the information provided by the bidder, keeping in mind the most financially profitable solution for the IAMD COE. Bids were evaluated under the factor of lower cost;

1.6.2 Compliance and eligibility: It has been confirmed that the bidder and his bid is in full compliance with the bidding terms and instructions, the general provisions (terms - conditions) and the special provisions - technical specifications defined in the respective IFB in order to be accepted for further evaluation;

1.6.3 Determination of Contractor responsibility: It has been certified that the prospective contractor has a satisfactory performance record and a satisfactory record of integrity and business ethics including compliance with applicable tax and labour-employment laws, as well as he maintains effective control of the quality of their products/services;

1.6.4 Competition requirements: It is confirmed that a competitive bidding process has been implemented and any potential bidders received impartial, fair, and equitable treatment (including the proper commercial-in-confidence handling of commercial bids) through publishing an invitation for bidding at the Central Electronic Public Procurement Registry (KIMDIS) and on the sourceONE application (e-procurement / e-tender platform);

1.6.5 Cost-effective and efficient contracting: It is ensured that the prospective contractor is in compliance with the procurement terms and conditions achieving the most cost effective and efficient solution for the majority of the Centre's needs (for all items requested apart from the PC monitors the proposed price of which is deemed uneconomic considering the results of the respective market research and open price catalogues);
