1.4 The Call For Competition (CFC) No FINCON 23-09, as Reference E, concerning the Research & Development (R&D) project of designing and creating "*Artificial Intelligence (AI) - Empowered Drone Detection Passive Radar using 5G signals*" for the benefit of the IAMD COE;

1.5 The "Institute of Computer Science (ICS), Foundation for Research and Technology - Hellas (FORTH)" hereafter referred to as "FORTH-ICS" (TAX ID Number: EL090101655, N. Plastira 100, Vassilika Vouton, GR-700 13 Heraklion, Greece) proposal, dated 12 December 2023 (16:27), as received through sourceONE internet application (Request for Quote with code: cfc-iamd-164268);

1.6.1 Evaluation strategy: The evaluation focused on information provided by the bidder, with an emphasis on identifying the most financially profitable, operationally effective and cost-efficient solution for the IAMD COE;

1.6.2 Compliance and eligibility: Confirmation has been received that the bidder and its bid fully comply with the bidding terms, general provisions (terms and conditions), and the special provisions - technical specifications outlined in the respective CFC. This compliance is a prerequisite for further evaluation;

1.6.3 Determination of Contractor responsibility: It has been certified that the prospective contractor possesses a satisfactory performance record adheres to ethical business practices, and complies with applicable tax and labor-employment laws, including compliance with applicable tax and labour-employment laws, as valid (tax and insurance - employer) clearance certificates;

1.7 The fact that the bid submitted from "FORTH-ICS" (TAX ID Number: EL090101655) is deemed the most cost effective and efficient solution, taking also into consideration not only cost factors but also acknowledging the innovative research and development process required to deliver the project outcomes;


