<u>PURPOSE</u>: SC to be approve the proposed Job Description IAMD-FNS12 CIS

Technician as enclosure 1.

BACKGROUND: Based on the growing activities of the Centre both on the operational

(Programme of Work) and the supporting level (CIS facilities due to the movement to the new building), a new Organizational Chart was deemed necessary. The new building will have upgraded network capabilities (four (4) different networks, black and red), the confidentiality and the integrity is the main target and requires a daily supervision

and support.

ANALYSIS & STATUS:

Taking into consideration the experience acquired since the Centre's establishment up to now, the requirement for a new CIS Technician is essential because of the arising obligations that will come up after the movement to the new building.

The new CIS Technician is a post in the Framework Nation Support (FNS) Branch of the IAMD COE, responsible for support and maintenance of the CIS hardware and software. The CIS Technician acts as the Configuration control Manager for all CIS equipment.

Following the provision of the new post, the respective Job Description (JD) has been prepared (as enclosure 1).
