1.5 The “Institute of Computer Science (ICS), Foundation for Research and Technology - Hellas (FORTH)” hereafter referred to as “FORTH-ICS” (TAX ID Number: EL090101655, N. Plastira 100, Vassilika Vouton, GR-700 13 Heraklion, Greece) proposal, dated 09 December 2024 (11:26), as received through sourceONE internet application (Request for Quote with code: fnc-iamd-185168);

1.6 The following:

1.6.1 Evaluation strategy: The evaluation focused on information provided by the bidder, with an emphasis on identifying the most financially profitable, operationally effective and cost-efficient solution for the IAMD COE;
